<u>15-07-2024</u> (Monday)	Approval of Election Schedule by the Executive Committee.
<u>18-07-2024</u> (Thursday)	Issuance of Election Schedule a) Display of Election Schedule at Notice Board of the Association. b) Display of Election Schedule at the Website of the Association. c) Submitted to the Regulator (TO).
<u>20-07-2024</u> (Saturday)	Member firms desiring to change their representative shall intimate changes Regarding name of representative to Secretary General along with necessary Proof of eligibility.
<u>23-07-2024</u> (Tuesday)	Display of Provisional List of all members eligible to vote along with their National Tax Number, Sales Tax Registration Number, if applicable, the name and CNIC No. of the Representative. The list shall be displayed at; a) Notice Board of the Association and b) Website of the Association
<u>26-07-2024</u> (Friday)	Last date for receipt of any objection in written to the Secretary General from the members to the entries in the list of voters.
<u>31-07-2024</u> (Wednesday)	Last date for intimation by the Secretary General of the action on the Objections or changes sent by the members.
<u>03-08-2024</u> (Saturday)	Last date for making representation to the Election Commission by any person Aggrieved of the decision of the Secretary General.
<u>06-08-2024</u> (Tuesday)	Last date for making decision by the Election Commission against the decision of the Secretary General.
<u>09-08-2024</u> (Friday)	Last date for filing of appeal to the Regulator by the person aggrieved by the Decision of the Association or in case the Commission fails to decide within the stipulated time.
<u>19-08-2024</u> (Monday)	Last date for taking decision by the Regulator on the appeals, if any.
<u>21-08-2024</u> (Wednesday)	Display of Final Voters List at Notice Board and Website of the Association as well as submission to the Regulator. Provided that if no appeal has been filed to the Regulator, the final list of voters shall be displayed within fifteen days of the decision of the Election Commission Under Sub Rule (6).
<u>24-08-2024</u> (Saturday)	Last date for receipt of Nomination Papers from the members, eligible to contest the election for the vacant post, duly proposed and seconded by a dully registered voter and signed by the candidate to the Secretary General.
<u>26-08-2024</u> (Monday)	Provision of a copy of the final list of voters to each contesting candidate.
<u>27-08-2024</u> (Tuesday)	Scrutiny of Nomination Papers by the Election Commission at 11:00 in the Association and display of list of candidates.
<u>28-08-2024</u> (Wednesday)	Last date for filling of objections, if any, to the Nomination of candidates to the Election Commission.



30-08-2024 (Friday)	Last date for making decision by the Election Commission on the objections, if any, to the Nomination of the Candidates.
02-09-2024 (Monday)	Last date for filing of appeal to the Regulator by any candidate aggrieved by the decision of the Commission or in case, Commission fails to decide within the stipulated time.
07-09-2024 (Saturday)	Last date for taking decision by the Regulator against an appeal filed by an aggrieved candidate.
09-09-2024 (Monday)	Issuance of final list of candidates by the Election commission
14-09-2024 (Saturday)	Polling for Election of members of Executive Committee from Corporate Members & Associate Members shall be held at the registered office of this Association from 09:00 hours to 17:00 hours.
18-09-2024 (Wednesday)	Last date for filing of Nomination Papers for election as an Office Bearer duly Proposed and seconded by an elected Executive Committee member and signed by the Candidate to the Election Commission.
19-09-2024 (Thursday)	Scrutiny of Nomination Papers by the Commission and display of final display of final list of candidates.
21-09-2024 (Saturday)	Polling for election of Office Bearers shall be held.
30-09-2024 (Monday)	Annual General Meeting, The final election results announced in the Annual General Meeting shall be; d) Displayed at the Notice Board of the Association within two (02) days. e) Displayed at the Website of the Association within two (02) days. f) Submitted to the Regulator within seven (07) days.

If any of the dates specified in the Election Program 2024-26 is a public holiday, it shall be substituted by the date following on the next working day.
